Plain Meaning Rule

Plain Meaning Rule is a foundational principle in statutory interpretation that directs courts to give effect to the ordinary, everyday meaning of the language used in a statute, unless the context or the purpose of the legislation clearly indicates otherwise. The rule rests on the premise that the legislature expresses its intent through the words it chooses, and that those words should be understood in the way a reasonable person would comprehend them at the time the law was enacted. This approach is often contrasted with more purposive or expansive methods of interpretation, but it remains a central tool for judges, lawyers, and scholars seeking to determine the scope and application of legislative provisions.

The following key terms and vocabulary are essential for mastering the Plain Meaning Rule and for navigating the broader field of statutory interpretation. Each entry includes a definition, an illustration, and a discussion of practical implications and potential challenges. Statutory Text refers to the exact words, phrases, and sentences that appear in the enacted law. It is the primary source of meaning under the Plain Meaning Rule. For example, a statute might state that “any vehicle parked in a no-parking zone shall be towed.” The phrase “any vehicle” is the statutory text that must be examined. Practitioners first isolate the relevant text, then apply ordinary linguistic analysis to determine its meaning. The challenge arises when the text is ambiguous or when it contains technical jargon that may not have a clear everyday meaning. In such cases, courts may look beyond the plain words to legislative history or purpose, but the starting point is always the statutory text itself.

Ordinary Meaning is the meaning that a word or phrase would convey to a reasonable person, without recourse to specialized definitions or technical dictionaries. This concept is central to the Plain Meaning Rule. For instance, the word “vehicle” in everyday language includes cars, trucks, motorcycles, and even bicycles. However, if a statute uses “vehicle” in a context that clearly excludes certain categories, the ordinary meaning may be narrowed by contextual clues. The practical application of ordinary meaning requires familiarity with common usage at the time of enactment, which may differ from contemporary usage. The challenge is that language evolves, so courts sometimes must reconstruct historical usage to remain faithful to the original intent.

Literal Interpretation is the process of applying the ordinary meaning to the statutory text without adding any external considerations. This method is often synonymous with the Plain Meaning Rule, though some jurisdictions distinguish between a purely literal approach and a more nuanced “plain meaning” that allows for modest contextual adjustments. A literal interpretation of the phrase “no parking on Sundays” would forbid parking on any Sunday, regardless of time of day. The advantage of literal interpretation lies in its predictability and the restraint it imposes on judicial discretion. The difficulty emerges when a literal reading produces an absurd or unreasonable result, prompting courts to invoke exceptions to the rule.

Contextual Analysis involves examining the surrounding words, the structure of the statute, and the broader

legislative scheme to determine whether the ordinary meaning fits within the overall purpose. While the Plain Meaning Rule emphasizes the text itself, contextual analysis acknowledges that words do not exist in isolation. For example, a provision that bans “vehicles” from a historic park may, when read in context, be intended to exclude only motorized vehicles, because the overall purpose of preserving the park’s tranquility suggests that bicycles are permissible. Contextual analysis helps avoid overly rigid applications that could undermine legislative goals. The challenge is balancing respect for the text with the need to interpret it in a manner consistent with the statute’s objectives.

Legislative Intent is the purpose or goal that the lawmakers sought to achieve when drafting the statute. Although the Plain Meaning Rule prioritizes the text, courts often consider legislative intent when the plain words are ambiguous or lead to an unreasonable outcome. Legislative intent can be inferred from committee reports, floor debates, and other legislative history. For instance, if a law was passed to protect endangered species, and the term “habitat” is used, courts may look to the legislative record to determine whether “habitat” includes only natural areas or also man-made environments. The challenge is that legislative history can be voluminous and sometimes contradictory, requiring judges to weigh competing sources and make judgments about which statements best reflect the collective will.

Presumptions of Construction are legal doctrines that guide how statutes are interpreted when the plain meaning is unclear. Two common presumptions are the presumption against surplusage and the presumption of constitutionality. The former assumes that every word in a statute has a purpose; therefore, no language should be ignored as meaningless. The latter holds that statutes should be interpreted in a way that avoids constitutional conflicts, if possible. These presumptions operate alongside the Plain Meaning Rule and help resolve ambiguities by providing default rules that steer interpretation toward a coherent and lawful reading. The difficulty lies in applying these presumptions without overstepping the boundary of textualism.

Doctrine of Ejusdem Generis is a rule of construction that applies when a general term follows a list of specific items. The doctrine directs that the general term should be interpreted to include only items of the same kind as those listed. For example, a statute that prohibits “cars, trucks, motorcycles, and other vehicles” would, under ejusdem generis, limit “other vehicles” to those similar to cars, trucks, and motorcycles, thereby excluding, say, airplanes. This doctrine illustrates how the Plain Meaning Rule can be refined by looking at the relationship between words. The practical challenge is determining what constitutes “the same kind” and ensuring that the interpretation aligns with the statutory purpose.

Doctrine of Noscitur a Sociis translates to “a word is known by its associates.” It requires that a term be interpreted in light of surrounding words. For instance, the phrase “bank, trust, or other financial institution” would be read to include only institutions that are financial in nature, because “bank” and “trust” give meaning to “other.” This doctrine supports a contextual approach while still respecting the textual focus of the Plain Meaning Rule. The difficulty is that the association may be ambiguous, especially when the list includes diverse items, making it harder to infer a narrow meaning.

Rule of Leniency (also called the rule of lenity) is a principle that, when a criminal statute is ambiguous, courts should interpret it in favor of the defendant. This rule reflects the notion that penal statutes must be clear so that individuals have fair notice of prohibited conduct. In the context of the Plain Meaning Rule, the

rule of leniency acts as a safeguard against overly broad readings that could criminalize behavior unintentionally. The challenge is that determining ambiguity can be subjective, and the rule may conflict with other interpretive tools that aim for a broader reading of the text.

Statutory Definition occurs when a statute itself provides a specific meaning for a term used within the law. For example, a law may define “employee” as “any person who performs services for wages under a contract of employment.” When a statutory definition exists, the Plain Meaning Rule directs courts to apply that definition, even if the ordinary meaning would differ. This ensures uniformity and respects the legislature’s explicit choices. However, problems arise when the definition is vague or when later provisions use the defined term in a way that seems inconsistent with the original definition. Courts must then reconcile the definition with the overall statutory scheme.

Ambiguity refers to a situation where a statutory phrase can be reasonably understood in more than one way. Ambiguity triggers the need for interpretive aids beyond the plain text. For example, the phrase “reasonable time” can be ambiguous because “reasonable” is a relative standard. The presence of ambiguity does not automatically invalidate the Plain Meaning Rule; rather, it signals that additional analysis—such as examining legislative history, purpose, or applying presumptions—may be necessary. The challenge is that identifying ambiguity often depends on the interpreter’s perspective, leading to debates over whether a term truly lacks a single clear meaning.

Strict Construction is an interpretive approach that adheres closely to the literal wording of the statute, limiting the role of external sources. This method aligns closely with the Plain Meaning Rule and is often favored in contexts where judicial restraint is paramount, such as tax law or criminal statutes. Strict construction promotes predictability and respects the separation of powers by preventing courts from effectively rewriting legislation. Yet, strict construction may produce outcomes that conflict with the statute’s purpose, especially when the language is outdated or overly broad.

Purposive Construction stands in contrast to strict construction by emphasizing the underlying purpose of the legislation. Under a purposive approach, courts may look beyond the plain words to achieve the law’s objectives, even if that requires a broader reading. While the Plain Meaning Rule is not incompatible with purposive construction—because the plain meaning may already reflect purpose—purposive construction becomes prominent when the text is ambiguous or when a literal reading would frustrate the law’s goals. The challenge is that purposive construction can grant judges considerable discretion, raising concerns about judicial overreach.

Chevron Deference is a doctrine from administrative law that instructs courts to defer to an agency’s reasonable interpretation of an ambiguous statute it administers. Although not a direct component of the Plain Meaning Rule, Chevron deference illustrates how the rule interacts with executive interpretation. When a statute is ambiguous, and an agency provides a reading, courts may apply the agency’s interpretation if it is reasonable, thereby limiting the need for a purely textual analysis. The practical implication is that statutory interpretation can be shaped by the expertise of agencies, but critics argue this undermines the primacy of the plain text.

Chevron Two-Step Test outlines the process for applying Chevron deference. The first step asks whether the

statute's language is clear; if it is, the court must follow the plain meaning. If the language is ambiguous, the second step asks whether the agency's interpretation is permissible. This framework demonstrates the hierarchical relationship between statutory text and agency expertise. In practice, the test underscores the importance of the Plain Meaning Rule as the initial gatekeeper: Only when the text fails to convey a clear meaning does the analysis proceed to agency deference.

Interpretive Presumption is a general principle that guides how statutes are understood when the wording is not decisive. Common presumption includes the idea that statutes are to be read in a way that gives effect to all provisions, avoiding "dead-letter" clauses that have no practical effect. These presuppositions complement the Plain Meaning Rule by providing a logical structure for resolving uncertainties. For example, the "presumption of consistency" holds that a later amendment does not alter earlier provisions unless expressly stated. The challenge is that presumption may conflict with the literal wording, requiring courts to balance textual fidelity against systemic coherence.

Rule of Construction is a broader term encompassing all the doctrines and presumptions that help shape statutory interpretation. The Plain Meaning Rule is one specific rule within this larger family. Other rules of construction—such as *eiusdem generis*, *noscitur a sociis*, and the presumption against surplusage—work together to create a cohesive interpretive framework. Understanding the hierarchy and interaction of these rules enables practitioners to navigate complex statutes more effectively. The difficulty lies in determining which rule takes precedence when multiple rules suggest different outcomes.

Statutory Purpose is the overarching objective that the legislature intended to achieve through the law. Identifying the purpose often involves examining the problem the statute seeks to solve, the policy considerations, and the social context at the time of enactment. While the Plain Meaning Rule emphasizes that the purpose should be inferred from the text, courts may resort to purpose when the plain meaning is ambiguous or leads to absurd results. For instance, a law aimed at protecting public health may be interpreted to require more stringent standards than the literal wording suggests, if doing so aligns with the legislative purpose. The challenge is that purpose can be contested, with different stakeholders offering divergent narratives about what the law was meant to accomplish.

Legislative History comprises documents such as committee reports, floor debates, and drafting notes that provide insight into the lawmakers' thinking. When the plain text is insufficient, courts may consult legislative history to clarify ambiguous terms. However, reliance on legislative history can be controversial because it may allow judges to cherry-pick statements that support a preferred outcome. The Plain Meaning Rule discourages excessive reliance on legislative history, but it does not forbid it altogether. Practically, attorneys must be adept at locating relevant historical materials and presenting them persuasively to support their interpretive arguments.

Canons of Construction are established principles that guide the interpretive process. They include both textualist canons—such as the plain meaning rule, the presumption against surplusage, and the rule of lenity—and purposive canons, like the mischief rule and the purposive approach. Canons serve as tools that help judges systematically analyze statutes, ensuring consistency and coherence. The Plain Meaning Rule is often considered the primary canon, with others acting as subsidiary aids. The difficulty is that canons can sometimes point in opposite directions, requiring judges to prioritize and reconcile them.

Mischief Rule is a historic common-law principle that asks what “mischief” the statute was intended to remedy, and then interprets the language to suppress that mischief. Though more aligned with purposive interpretation, the mischief rule can be invoked when the plain meaning fails to address the problem the legislation sought to correct. For example, a law criminalizing “the use of a vehicle for illegal activity” might be applied to a motorbike used for drug trafficking, even if a literal reading could be argued to exclude motorbikes. The mischief rule thus provides a bridge between textual fidelity and policy goals, but it also introduces a degree of judicial discretion that may be at odds with strict textualism.

Expressio Unius Est Exclusio Alterius translates to “the expression of one thing is the exclusion of another.” This canon suggests that when a statute lists specific items, it intends to exclude items not listed. In practice, if a law enumerates “cars, trucks, and motorcycles,” the principle would imply that bicycles are not covered. The rule works hand-in-hand with the Plain Meaning Rule by reinforcing the idea that the legislature’s choice of words is deliberate. However, the principle can be problematic when the list is not exhaustive, and the court must decide whether the omission was intentional or merely an oversight.

Rule of Construction Against Retroactivity holds that statutes are generally presumed to operate prospectively, unless the language clearly indicates otherwise. This presumption aligns with the Plain Meaning Rule because the literal text often reveals whether retroactive application is intended. For example, a law stating that “effective January 1, 2025, all contracts must include clause X” is plainly prospective. The rule protects individuals from unexpected changes to legal obligations. The challenge arises when the statutory language is vague about temporal application, requiring courts to infer the legislature’s temporal intent.

Rule of Construction for Penal Statutes emphasizes that criminal laws should be interpreted narrowly, ensuring that individuals have fair warning of prohibited conduct. This rule dovetails with the rule of lenity, reinforcing a protective stance toward defendants. When a penal provision contains an ambiguous term such as “dangerous instrument,” courts may opt for a narrow construction that limits liability to objects commonly understood as dangerous. The practical effect is that the Plain Meaning Rule is tempered by a policy of protecting liberty, especially where the stakes of misinterpretation are high.

Interpretive Gap occurs when a statute fails to address a particular circumstance, leaving a void in the law. The Plain Meaning Rule cannot fill an interpretive gap because there is no text to interpret. In such instances, courts may resort to the doctrine of “implied powers” or look to analogous statutes to supply the missing rule. For example, a tax code that does not specify how to treat a novel digital asset may create an interpretive gap that requires the judiciary to develop a solution. The difficulty lies in ensuring that the gap-filling measure respects the legislature’s authority without overstepping it.

Rule of Construction for Ambiguities in Tax Law is a specialized application of the Plain Meaning Rule that often requires a purposive approach because tax statutes are frequently complex and technical. Courts may interpret ambiguous tax provisions in a way that favors the taxpayer, reflecting the principle that taxes should be clear and predictable. For instance, if a tax statute mentions “income derived from services,” a court may interpret this phrase to include both fee-based and salary-based earnings, unless the legislative history indicates a narrower scope. The balancing act here involves honoring the plain text while ensuring equitable tax administration.

Interpretive Standard is the level of rigor or deference a court applies when interpreting a statute. Under the Plain Meaning Rule, the standard is high: The court seeks to give effect to the text's ordinary meaning. Other standards, such as Chevron deference or Skidmore deference, lower the court's level of scrutiny, allowing agencies greater latitude. Understanding the applicable interpretive standard is crucial for predicting how a court will treat ambiguous language. The challenge is that different jurisdictions may adopt varying standards, creating a patchwork of interpretive regimes.

Statutory Construction is the overall process of interpreting legislative language, encompassing all the tools, doctrines, and principles discussed herein. The Plain Meaning Rule is a central component, but construction also involves contextual analysis, purposive inquiry, and the application of various canons. Effective statutory construction requires a methodical approach: First, identify the relevant text; second, determine its ordinary meaning; third, assess the surrounding context; and finally, consider purpose, legislative history, and any applicable presumptions. The difficulty for practitioners is mastering each step and knowing when to shift from a textual focus to a broader interpretive lens.

Rule of Construction for Ambiguities in Criminal Law mirrors the rule of lenity, emphasizing that doubts should be resolved in favor of the accused. When a criminal statute contains an ambiguous phrase like "use of a dangerous weapon," courts may interpret "dangerous" narrowly to avoid encompassing benign objects. This protective stance aligns with constitutional guarantees of due process and the principle that penal laws must be clear. The practical implication is that prosecutors must draft charges with precise language, and defense attorneys can leverage ambiguities to challenge the sufficiency of the statutory basis for conviction.

Judicial Restraint is a philosophy that encourages courts to limit their role in policy making, adhering closely to the text of statutes and the Constitution. The Plain Meaning Rule embodies judicial restraint by insisting that judges do not rewrite legislation based on personal preferences or policy goals. In practice, judicial restraint promotes stability and predictability in the legal system. However, strict adherence to the plain text can sometimes produce outcomes that appear at odds with contemporary values or social needs, prompting debates about whether a more flexible approach is appropriate.

Judicial Activism is the opposite of judicial restraint, describing a tendency for courts to interpret statutes in ways that advance policy objectives or rectify perceived legislative shortcomings. While the Plain Meaning Rule discourages activism by grounding decisions in the statutory text, some judges may still invoke broader interpretive tools to achieve socially desirable outcomes. Critics argue that activism undermines democratic processes, whereas proponents contend that it can correct legislative oversights. Understanding the tension between these philosophies helps learners appreciate why the Plain Meaning Rule remains a cornerstone of textualist interpretation.

Textualism is an interpretive methodology that focuses exclusively on the statutory language, treating the text as the sole source of meaning. Textualists champion the Plain Meaning Rule as the primary mechanism for uncovering legislative intent. They argue that the text is the most reliable indicator of what the legislature intended, because it is subject to public scrutiny and political accountability. The practical advantage of textualism is that it limits judicial discretion and promotes uniformity. The challenge for textualists is dealing with ambiguous or outdated language, which may require supplemental tools that appear to conflict with a pure textualist stance.

Purposivism is an interpretive approach that emphasizes the law's purpose, even when it requires looking beyond the literal words. Purposivists accept the Plain Meaning Rule as a starting point but are willing to depart from it if doing so better serves the statute's objectives. For instance, an environmental statute that uses the term "substantially reduce" may be interpreted purposively to require a significant reduction, rather than a minimal one, based on the legislative goal of protecting ecosystems. The difficulty with purposivism is that it can grant judges considerable leeway, potentially leading to unpredictable or inconsistent outcomes.

Dynamic Interpretation refers to the idea that statutes can evolve in meaning over time, adapting to new circumstances and societal changes. While the Plain Meaning Rule emphasizes the original meaning at the time of enactment, dynamic interpretation acknowledges that language can acquire new connotations. Courts employing a dynamic approach may reinterpret "vehicle" to include autonomous drones if technology advances beyond the legislature's original conception. This perspective balances fidelity to the text with responsiveness to contemporary realities. The challenge is ensuring that dynamic interpretation does not become a pretext for judicial overreach.

Originalism is a doctrine chiefly associated with constitutional interpretation, but it also informs statutory construction by urging courts to ascertain the meaning that the text had at the time of enactment. Originalism aligns closely with the Plain Meaning Rule, as both seek to honor the legislature's original intent. Practically, originalist analysis requires historical research into the language, usage, and societal context of the period when the law was passed. Critics argue that originalism can be inflexible, failing to accommodate modern developments, while supporters claim it preserves the rule of law by preventing retroactive reinterpretation.

Statutory Silence occurs when a law does not address a particular issue, leaving a gap. The Plain Meaning Rule cannot fill silence because there is no text to interpret. Courts may then look to general principles of law, analogous statutes, or the doctrine of "implied powers" to infer a reasonable rule. For example, if a consumer-protection statute is silent on digital transactions, a court may apply the broader consumer-protection principles to cover online sales. The difficulty lies in ensuring that the inferred rule does not exceed the legislature's authority.

Presumption of Regularity assumes that governmental actions, including the drafting of statutes, are performed correctly and in accordance with established procedures. This presumption supports the Plain Meaning Rule by implying that the legislature's language is deliberate and accurate. When a statutory provision appears to contain a drafting error, the presumption of regularity encourages courts to search for a plausible interpretation that aligns with the overall legislative scheme, rather than assuming a mistake. The challenge arises when the alleged error is so severe that any reasonable construction seems forced.

Rule of Construction for Ambiguities in Administrative Law often combines the Plain Meaning Rule with Chevron deference. When an administrative regulation is ambiguous, courts first examine whether the statutory text is clear. If the text is clear, the plain meaning controls; if not, the court evaluates the agency's interpretation. This layered approach ensures that the statutory text retains primacy while acknowledging the expertise of administrative bodies. Practically, lawyers must be adept at both textual analysis and the preparation of agency arguments to influence the outcome.

Interpretive Hierarchy is the ordering of interpretive tools from most to least authoritative. At the top sits the statutory text, interpreted via the Plain Meaning Rule. Below that are legislative history, purpose, and policy considerations, followed by subsidiary rules such as *ejusdem generis* and *noscitur a sociis*. Understanding this hierarchy helps practitioners prioritize arguments and anticipate how a court will weigh competing interpretive factors. The difficulty is that different jurisdictions may adjust the hierarchy, especially regarding the weight given to legislative history versus purpose.

Rule of Construction for Ambiguities in Contracts—although not a statutory context—mirrors the approach taken in statutory interpretation. Courts first apply the plain meaning of contractual language, then consider the purpose of the agreement, and finally look to extrinsic evidence if ambiguity remains. The parallel underscores the broader applicability of the Plain Meaning Rule across legal domains. In practice, contract drafters aim for clarity to avoid reliance on interpretive tools that could introduce uncertainty.

Doctrine of Implied Repeal holds that a later statute can implicitly repeal an earlier one if the two are irreconcilably inconsistent. The Plain Meaning Rule assists in identifying such conflicts by focusing on the ordinary meaning of each provision. If the later statute's language plainly contradicts the earlier one, the court may infer an implied repeal. The challenge is that courts are reluctant to find implied repeals, preferring to preserve the validity of both statutes if possible, and instead resort to harmonious construction.

Rule of Construction for Ambiguities in Securities Law often incorporates the principle that securities regulations are to be interpreted in a manner that promotes market integrity. The Plain Meaning Rule serves as the baseline, but courts may also apply the "purpose" test to ensure that the regulation fulfills its protective function. For example, the phrase "material information" may be given a broad ordinary meaning to capture any data that could affect investor decisions, reflecting the policy aim of preventing fraud.

Rule of Construction for Ambiguities in Immigration Law is characterized by a tendency toward liberal interpretation of the statutory text in favor of the individual, especially when the language is vague. The Plain Meaning Rule is applied, but courts are mindful of humanitarian considerations and the "fair-play" principle, which can lead to broader readings of ambiguous provisions. This approach recognizes the high stakes for non-citizens and the need for clear guidance from the statutes.

Rule of Construction for Ambiguities in Employment Law often balances the plain meaning of contractual terms with the protective purpose of labor statutes. When a provision uses the term "employee," the Plain Meaning Rule directs the court to apply the ordinary definition, but the purpose of the law—protecting workers—may expand the scope to include gig-workers or independent contractors if the statutory context suggests such an intent. The challenge is to reconcile the text with evolving labor market realities.

Rule of Construction for Ambiguities in Environmental Law emphasizes that statutes are interpreted to achieve environmental protection goals. The Plain Meaning Rule is the starting point, but courts may adopt a purposive stance to ensure robust safeguards. For instance, the term "pollutant" may be interpreted broadly, even if the ordinary meaning would be narrower, because the legislative purpose is to prevent environmental harm. This illustrates how the plain meaning can be stretched within the bounds of policy objectives.

Rule of Construction for Ambiguities in Intellectual Property Law often requires a careful balance between the literal language of statutes and the underlying policy of encouraging innovation. The Plain Meaning Rule is applied to terms like "invention" or "creative work," but courts may also consider the purpose of granting exclusive rights to promote progress. For example, the phrase "non-obvious" in patent law is given a specific technical meaning that reflects both ordinary understanding and specialized legal standards.

Rule of Construction for Ambiguities in Family Law typically favors clear, literal readings to provide certainty in matters such as child custody and property division. However, the best interests of the child principle may lead courts to interpret ambiguous statutes in a way that best serves the child's welfare, even if that requires a broader reading than the plain text suggests. The interplay between the Plain Meaning Rule and policy considerations highlights the delicate balance courts must strike.

Rule of Construction for Ambiguities in Banking Law often adopts a strict approach, emphasizing the plain meaning of financial terms to maintain market stability. The Plain Meaning Rule is reinforced by the need for predictability in financial transactions. Nevertheless, when statutes are vague, courts may invoke the purpose of consumer protection to interpret ambiguous language in favor of depositors.

Rule of Construction for Ambiguities in Taxation frequently employs the principle that tax statutes should be interpreted in a way that does not increase tax liability unless the language is clear. This is an application of the rule of lenity within tax law. The Plain Meaning Rule serves as the first step; if the tax provision's wording is ambiguous, the court will resolve the ambiguity in the taxpayer's favor. This protective stance promotes fairness and encourages legislative clarity.

Rule of Construction for Ambiguities in Bankruptcy Law underscores that statutes governing insolvency must be read plainly to provide certainty for creditors and debtors alike. The Plain Meaning Rule is applied rigorously, but courts may also consider the purpose of facilitating an orderly discharge of debts, which can influence the interpretation of ambiguous terms like "dischargeable." The challenge is to balance the literal text with the policy goal of economic stability.

Rule of Construction for Ambiguities in Antitrust Law often requires a purposive reading to preserve competition. While the Plain Meaning Rule guides the initial analysis, courts may look beyond the text to ensure that the statute's anti-monopoly purpose is fulfilled. Rule of Construction for Ambiguities in Health Care Law typically involves a blend of textual and purposive analysis, given the complex nature of medical regulations. The Plain Meaning Rule is applied to terms such as "covered services," but the policy goal of ensuring access to care may lead to a broader reading when the statutory language is unclear.

Rule of Construction for Ambiguities in Education Law focuses on interpreting statutes in a manner that advances educational equity and access. The Plain Meaning Rule serves as the starting point, but ambiguous language concerning "students with disabilities" may be interpreted expansively to fulfill the purpose of inclusive education.

Rule of Construction for Ambiguities in Aviation Law emphasizes safety and regulatory compliance.
